RELEASE AND TRAINING CONTRACT

PAYMENT

Payment is due at the time of reservation of a class or private appointment. **In the event of a check being returned for any reason, a \$25 fee will be assessed and cash payment required. Missed classes cannot be made up.**

REFUNDS

Best Dog stands by its training and offers a satisfaction guarantee. If you are not satisfied with your dog's behavior or performance, you are welcome to retake the course one (1) time to achieve your desired behavior and/or performance. Other training strategies and/or recommendations will be discussed between client and trainer at this time. There will be no refund of a monetary nature given if client is not satisfied with services.

PRIVATE LESSONS

Private lessons must be cancelled at least 48 hours in advance of the lesson, and by speaking directly with a Best Dog employee. Failure to do this will result in being billed for the lesson.

VACCINATIONS

All dogs that come to Best Dog's facility for training must be fully vaccinated by a licensed veterinarian. Owners must show documentation of current vaccinations and have a copy on file. We will not accept a dog for training that has had any vaccines within ten (10) days. Any dog that has not received its full schedule of vaccinations, including Bordetella, Parvo/Distemper, and Rabies will not be allowed to participate in a training program.

BEHAVIORAL ADVICE

I recognize that there may be an element of risk in dog behavioral training/handling. **Behavioral advice and training suggestions are provided at the Client's own risk. Use of this information is voluntary and Best Dog is not responsible for consequences.** I understand that participation in Best Dog's Training and Behavior Modification's Group Classes, private sessions, seminars and events are not without some risk, that despite all the dogs appearing healthy, and being handled with the greatest amount of care and foresight, dogs are not always predictable and the unexpected may occur. **Client hereby indemnifies and holds harmless Best Dog, Nora Birt, all officers, instructors, trainers, employees, independent contractors and insurers from any liability claims, demands, causes of action, anticipated or unanticipated, arising out of any loss.** I understand that the training my dog receives does not guarantee the dog's behavior in the future. I will pay for all veterinary bills related to my dog, or any bills of another dog that my dog harms. I hereby waive and release Best Dog from any injury or damage to my dog as the result of my dog escaping from the premises.

FIELD TRIPS (Where Field Trips are part of the training)

I hereby authorize the employees of Best Dog Training to transport my dog for a "field trip". I hereby waive and release Best Dog Training, its officers, employees, owners, members, and agents from any injury or damage resulting from the act of taking the dog on the field trip. I will pick up my dog on the agreed upon date. I realize that if I do not pick up my dog after 1 day, that I will be held liable for an additional boarding fee of \$50 per day. If I do not pick up my dog after 7 days, I will relinquish ownership of the dog and Nora Birt will be allowed to place the dog in another home. I realize that I am still responsible for the fees for training at the rate listed in this contract.
